and adoption of 2024-25 Controlled Open Enrollment Plan

In accordance with the provisions of Chapter 1003.03 Maximum class size. —F.S. each school district is required to review its facility utilization each year to determine if the district is in compliance with the maximum class size requirements and to determine how to address capacity issues.

Each year, the Planning and Growth Management Department takes a snapshot of the schools' capacity from the previous December and reports this information to the Long Range Planning Committee (LRPC).

It is noted that the recommendation will focus primarily on attendance boundaries, but it may also include options to pursue land for new facilities, build new facilities, add student stations to existing facilities, or pursue programmatic changes.

Enrollment data from the last five years is included in order to gauge changes that may indicate trends and for general information.

The Controlled Open Enrollment Plan enables the District to consider student assignment based on parental preference when requested by the parent as defined by Florida Statutes. It is being considered as part of the End of Year Report because it can also have a significant impact on the utilization of facilities. The proposed 2024-25 Controlled Open Enrollment Plan is attached to this report for consideration and adoption by the School Board.

Updates to the 2024-25 Controlled Open Enrollment Plan include the following:

1. Section I Provision for a parent to request placement of siblings within the same school – clarification that the preference to enroll siblings in an out of zone school is subject to school capacity.

- Section K Availability of transportation based on the ongoing bus driver shortage and high growth; it is recommended that transportation to an out of zone school be limited to students who are enrolled in school specific special programs.
- 3. Section L Automatic approval process for students that move out of zone This provision is being updated to require the schools to confirm that the student has changed their address before a zone waiver is processed.

By the end of 2023 overall K-12 enrollment increased from 15,210 in December of 2022 to 15,341 in December of 2023. This is a 0.9 percent increase as compared to 3.3 percent last year.

The 5 Year Work Plan has been updated for two years in a row to reflect accelerated growth in the Central Ridge Area including first plans for additional elementary school student stations at a new elementary school at the Pine Ridge School Site in the mid-term and now some additional elementary student stations at Rock Crusher Elementary School possibly before a new school can be constructed to accommodate growth in the Lecanto Area. This is necessary because of increased development activity, both housing starts as well as development projects in various phases of the review process in Southwest Citrus County.

The Suncoast Parkway connection to SR-44 has accelerated new single family home construction in the Central Ridge Area including Citrus Springs, Pine Ridge, Beverly Hills, and Hernando/Citrus Hills, as well as new subdivisions and proposed multi-family housing projects in the Lecanto and Rock Crusher Road areas.

The DOE Approved Floral City Elementary Expansion is planned for 2023-24 and the additional student stations that had been assigned to the final phase of this project have been shifted to Rock Crusher Elementary pending enough enrollment growth to warrant a twelfth elementary school.

Although the, FDOE COFTE projections do not warrant a new school in the 5 Year planning period, development activity has remained strong and proposed residential projects in the Beverly Hills and Lecanto areas indicate that additional student stations will be needed in both parts of the County following attendance boundary modifications that can be approved in the future to balance the enrollment between the elementary schools.

The Pine Ridge School Site was acquired by the School Board on November 17, 2011 so this site is available for elementary expansion when a new facility is warranted. The proposed Tuscany Project in Beverly Hills is currently under review as a Planned Unit

Development and this project will probably trigger the need for a 12<sup>th</sup> elementary school within the next decade. Currently, schools in this general (Central Ridge) area are running at 100 percent capacity on average compared to 97 percent last year. The projected average capacity for this area drops to 99 percent but Citrus Springs Elementary and Hernando Elementary will likely be at or above 104 percent.

The following is a snapshot of school capacity as of December 18, 2023:

## **High Schools**

In summary, the total (combined) FISH capacity for all three high schools is 4,960 student stations with 4,484 students enrolled on December 18, 2023. This leaves a surplus of 476 student stations, or approximately 10 percent excess capacity.

As of the reporting date all portable/temporary classrooms have been removed from the high schools.

As a result of the most recent high school rezoning in 2013-14, approximately 125 students were relocated from Lecanto High School to Crystal River High School to more fully utilize the new facilities at Crystal River High School and help balance out the utilization rates between the high schools.

The following is a summary of the current capacity conditions as compared with last year's conditions:

#### **Current Excess Capacity Estimate by High School:**

•	Lecanto High School	0%	(last year was 6%)
•	Citrus High School	17%	(last year was 15%)
•	<b>Crystal River High School</b>	13%	(last year was 16%)

#### Middle Schools

The total (combined) FISH capacity for all four middle schools is 4,321 student stations with 3,487 students enrolled on December 18, 2023. This leaves a surplus of 834 student stations, or approximately 19 percent excess capacity. No middle school has less than 8 percent excess capacity at the current time. No new middle school student stations are planned at this time. Higher growth at Citrus Springs Middle School was addressed by rezoning an area of Citrus Springs to Crystal River Middle School for the 2017-18 school year. This was done in phases by "grandfathering" students from two grade levels, 7<sup>th</sup> and 8<sup>th</sup> grade, instead of one. The target capacity at Citrus Springs Middle School was 85 percent for the 2019-20 school year and it is currently at 90 percent.

The current Work Plan does not indicate a need for additional middle school student stations within the 5-year planning term.

The following is a summary of the current capacity conditions as compared with last year's conditions:

## **Elementary Schools**

The total (combined) FISH capacity for all eleven elementary schools is 7,783 student stations with 7,370 students enrolled on December 18, 2023. This leaves a surplus of 413 student stations, or approximately 5 percent excess capacity. Last year there was 6 percent excess capacity.

The following is a breakdown of the current utilization rates in the context of the target rates from the most recent rezoning in 2017:

- Pleasant Grove Elementary Target 90 percent or lower Currently 84 percent
- Lecanto Primary Target 90 percent or lower Currently 96 percent
- Inverness Primary Target 85 percent or lower Currently 91 percent
- Homosassa Elementary Target 90 percent Currently 96 percent
- Floral City Elementary Target 80 percent Currently 78 percent
- Hernando Elementary Target 90 percent Currently 105 percent

Based on the 2023 Rezoning Study the target enrollment for 2025-26 will increase significantly to approximately 95 percent for each school with the exception of Floral City Elementary and it will be at approximately 84 percent following the capacity expansion projects. It is noted that the results of the rezoning study will likely need to be updated prior to implementation and this could result in changes to the projected enrollment and utilization rates of the elementary schools that are impacted.

The following is a summary of the current capacity conditions as compared with last year's conditions:

In summary, enrollment across the zoned schools is as follows:

The overall change in enrollment at the zoned schools is +131 from December 2022 to December 2023.

Note: Projected enrollment, based on cohort progression, was 15,496. Actual enrollment was 15, 341.

### **Summary of Residential Growth Related Capital Projects**

- 1. Remaining Safe Routes to School Sidewalk Project
  - Beverly Hills/ FRE Sidewalk Project Phase II from Lake Beverly to Colbert Court. – This project has been funded by the Board of County Commissioners (\$1.2 million) and scheduled for construction in 2026. This project extends the sidewalk to the maximum 2 miles from Forest Ridge Elementary School to the North.
- 2. Crystal River Middle School Parking and Traffic Circulation Improvement **Project** 
  - The CRMS Parking and Traffic Circulation Improvement Project is necessary due to growth in the facility and cars spilling over from the parent pick up area onto Crystal Street. It has been planned for several years and a concept design was completed prior to site acquisition.

• The Crystal River Middle School on Site Traffic Circulation Improvements / Parent Pick Up Area Project is scheduled for <u>Year 1</u> (2023-24) in the 2023-24 District Work Plan.

- 3. Inverness Middle School Parking and Traffic Circulation Improvement Project
  - The IMS Parking and Traffic Circulation Project may be necessary due to growth in the facility and cars spilling over from the parent pick up area onto Ella Street and Turner Camp Road. It has been planned for several years with unsuccessful attempts to acquire the needed property and secure access through a publicly owned and maintained roadway. Traffic issues may be mitigated to some extent by improvements to US-41 which are currently underway. The project will be designed to enhance the traffic flow after the planned improvements to the intersection of US-41 and Middle School Road are complete. This is a two-year project that started in November of 2023.
  - The Inverness Middle School On-Site Traffic Circulation Improvements / Parent Pick Up Area Project is scheduled for <u>Year 4</u> (2026-27) in the 2023-24 District Work Plan. It is currently unfunded but will be funded if issues with design options can be resolved and the project is needed after the US-41 improvements are completed.
- 4. Citrus High School/ Inverness Primary School Master Plan and Traffic Circulation Improvements
  - The Project has been moved to 2025-26 in the 5 Year Work Program.
- 5. Floral City Elementary School Expansion /Improvements
  - Floral City Elementary School expansion projects have been approved by DOE and are projected to take 2 years to complete:
  - Summer 2023 Kitchen and Dining Area Expansion Project
     This will add a multipurpose room, chair storage, a larger stage and
     dressing rooms in addition to kitchen and dining space. The project is
     under construction. However there have been some delays due to supply
     chain issues.
  - Summer 2024 New Classroom Wing
    This will add 102 student stations bringing the school total to 599, teacher
    planning office, custodial room, electrical room, material storage area and
    restrooms. This project is currently in the design phase.

> The District Work Plan had identified a latter phase for Floral City Elementary that would have taken it to 810 student stations at buildout. However, considering anticipated growth in the west central part of the County, 210 student stations have been shifted to the Rock Crusher Elementary site. Floral City Elementary School is currently approved to increase from 497 to 599 student stations by the Florida Department of Education.

- In preparation for the Floral City Elementary School expansion, a county wide rezoning study was completed in December 2023. This zoning study analyzed current enrollment at all zoned elementary schools as well as projected enrollment.
- It was conducted by PGM Staff in coordination with the Facilities and Construction Department and the Planning Department.
- The results indicate that approximately 10 percent of elementary students can be rezoned to optimize available space in 7 of the 11 elementary schools. At Forest Ridge Elementary, the open enrollment process is working well without the need to rezone currently. The analysis indicates that relocatable, or other additional student stations are needed at Rock Crusher Elementary to serve this school as well as adjacent schools including Homosassa Elementary and Lecanto Primary.
- A project to Master Plan the Rock Crusher Elementary School Campus has been added to the 5 Year Work Program for 2024-25 with an anticipated rezoning of 7 elementary schools in 2025-26 to align with the completed improvements at Floral City Elementary. This will provide maximum options to address growth throughout the county at the elementary level by 2025-26. In the meantime, the open enrollment process will be utilized to manage enrollment in all of the schools.

#### 6. Rock Crusher Elementary Expansion Project

A capacity project at the 104-acre Rock Crusher Elementary Site was added to the District Work Plan in 2022-23 to address anticipated growth from Lecanto area projected residential development. The 2023-24 Work Plan was updated to add \$100,000 in Year 2 (2024-25) to Master Plan the Rock Crusher Campus to address traffic circulation issues, to identify the best area for relocatable classrooms at Rock Crusher Elementary, and to identify the best location for a new Middle or Combination School on the Campus.

This will provide flexibility necessary to address anticipated growth in the Southwest part of Citrus County over the next decade. Based on current development proposals in the Lecanto Area, this site needs to be available in addition to the Pine Ridge School Site to add temporary student stations and permanent student stations as needed.

## Summary of Transportation Growth Related Capital Projects

- 7. County 491 Corridor Development Project
  - Phase I from SR-44 North to Audubon Park Medical Complex complete
  - Phase II from the Audubon Park Medical Complex 1.9 miles north to W. Parkville Street (Culver's Restaurant) Plans are complete, and the groundbreaking was in November 2023. The project is projected to last until December 2025. Traffic delays are expected during the two-year construction period because of the limits for alternative north to south traffic routes.
- 8. Suncoast Parkway II Project

This project officially began on September 12, 2018.

- Phase 1 US98 to SR44
   Project is complete.
- Phase 2 SR44 to CR486
   The contractor is Superior Asphalt Co.
   Project under construction.
   Cost \$76M Projected to be a 3 Year Project
- Phase 3a CR486 to CR 495
   Project is funded and in property acquisition phase.
   Construction is tentatively scheduled to start in 2025.
- Phase 3b CR495 to US19 at Red Level
   Project is funded and in property acquisition phase.
   Construction is tentatively scheduled to start in 2026.

All phases of the Suncoast Parkway II Project are now fully funded including design, property acquisition, and construction.

9. US-41 at IMS 2 Lane to 4 Lane Improvement Project

- Project Timeline:
- Groundbreaking November 30, 2023
- The project starts at SR-44 and extends North for one mile to the Withlacoochee Trail Bridge.
- Projected Completion Projected for Summer 2025
- The improvements include an additional lane in each direction with median separation, bicycle lanes, sidewalks with access to the Withlacoochee State Trail, and a dedicated left turn lane for the southbound traffic to Inverness Middle School.

Summary of Major Housing Developments in various stages of the Development Review Process (note; this is not an exhaustive list. These are considered to be the most likely projects to come to fruition based on the stages of the development review process and market conditions as of January 2024)

Beverly Hills – Tuscany Ranch

Project completes buildout of the old Beverly Hills Development of Regional Impact.

Proposes 1,000 multifamily units and up to 6,369 single family residential units as well as other 275,00 square feet of other non-residential land uses on 1,642 acres with access from County Road 491 and Forest Ridge Boulevard.

Pine Ridge - Amber Ridge West

Project is adjacent to the Pine Ridge School Site and YMCA. It proposes 382 single family residential units on 147.6 acres. This area is currently designated for significantly less density.

- Lecanto Crystal Ridge Phase I
  - Project has access from W. Crystal Oaks Drive and Rock Crusher Road. It proposes 236 single-family residential units on 52.4 acres.
- Lecanto Preserve (buildout of Crystal Glenn) 750 residential units and other uses on 139.1 acres with access from CR-491 near Lecanto School Complex
- Cardinal Node <u>Cardinal Farms</u> 434 Multifamily Apartment Units and 434 Single Family Detached/Town Homes/ Villas on 868 acres.

 Sugarmill Woods – <u>Southern Woods Phase V</u> – 160 Single Family Units under construction.

## <u>Summary of Enrollment for 2023 and Implications for 2024-25 Facility Utilization</u> (based on data used to complete 1<sup>st</sup> run projections for 2024-25)

As of January 19, 2024, the 2024-25 high school facility utilization is projected to be 93 percent.

The 2024-25 middle school facility utilization is projected to be 78 percent.

The growth is in elementary enrollment where the utilization is projected to be holding at 95 percent. Enrollment up 9 students from 2023.

The overall growth in elementary enrollment has slowed from last year but it is still consistent with the plans to expand Floral City Elementary and rezone students to redistribute them where capacity will be available over the next two to three years. This is necessary because of the pockets of growth throughout the central part of the County.

Looking at the distribution of growth it is apparent that additional student stations will be needed in the Southeast Quadrant of the County in addition to the 102 student stations at Floral City Elementary in order to accommodate students in Homosassa and Lecanto who are too far away to be transported to Floral City. Additional relocatable classrooms at the Rock Crusher Elementary School Campus is a cost effective temporary solution to potential growth in this area until an additional elementary school can be warranted in the center part of the County (Pine Ridge School Site).

In 2023 a rezoning study was conducted to develop a plan for relieving overcrowding in the elementary schools and to populate Floral City Elementary following DOE Approved improvements.

The rezoning study was conducted early in order to look at the big picture and also look at alternatives for schools that cannot be rezoned due to travel time issues for buses and parents.

Based on the rezoning study, rezoning can address the growth in all but three elementary schools during the current (5 Year) planning period. The three that cannot be rezoned include Homosassa Elementary, Rock Crusher Elementary, and Lecanto Primary. These schools are all currently near capacity, and an alternative plan needs to be developed to

address growth in the southwest part of the County due to the potential for residential construction before a new elementary school can be justified and constructed.

The current 10 Year COFTE projections do not indicate the need for an additional school, but they indicate that the elementary schools will be near capacity. These projections may be low based on current residential projects that are in the development review process.

Therefore, a good option would be to masterplan the 104 acre +/- Rock Crusher Elementary School Site so that it can transition from a single 699 student station facility to be able to accommodate a relocatable wing in the interim (by 2026-27) and a second school site if needed by 2032-37 or beyond.

The Rock Crusher site has a single entrance for cars and buses and this needs to be addressed as well as stacking for parent pick up and drop off. The master planning process could update the site for traffic circulation as well as provide for the optimum site for a future middle school or combination school.

The current 20 Year COFTE projections indicate a need for an additional elementary school with all levels, including middle and high at full capacity. Again, these numbers are very conservative.

With school sites already purchased in Pine Ridge, Sugarmill Woods, and Citrus Springs and Floral City Elementary School expanded to 599 student stations, master planning the Rock Crusher Campus as a transition site, will maximize the options for managing growth over the next 10 years.

The following is a potential timeline based on the current Work Plan and local residential development conditions:

- 2023-24 Rezoning Study
- 2023-24 Floral City Elementary Expansion Project to increase capacity to 599 student stations.
- 2024-25 Master Plan 104 acre +/- Rock Crusher Campus to transition to a multiple school site with relocatable classrooms in the interim.
- 2025-26 or 2026-27 Implement Rezoning Plan with updates as necessary.
- 2025-26 Improvements at Rock Crusher Campus to address traffic circulation and relocatable classroom infrastructure.

By 2026-27 these steps would allow for multiple options to address enrollment growth over the next 15 years along the Suncoast Parkway Corridor as it moves northward. These could include expanding the capacity of Rock Crusher Elementary to 800 student

stations, a new 800 student station elementary school on the 20 acre +/- Pine Ridge School Site (adjacent to the YMCA), a new middle school or combination school on the Rock Crusher Campus and a new high school or combination school at the 115 total acre +/- Citrus Springs School Site (adjacent to Central Ridge Elementary School)

### **Staff Recommendation:**

- 1. Readopt the current attendance boundaries for the elementary schools for 2024-25.
  - Monitor proposed projects and development approvals in the Rock Crusher Canyon Area and Crystal Glen Area for potential changes to the District Work Plan. This area has infrastructure available and is close to the Suncoast Parkway and well suited for workforce housing where school age population currently resides.
  - Monitor enrollment in the Central Ridge Area, including Citrus Hills, and south into Lecanto. These areas will be most impacted by residential development around the Suncoast Parkway as well as in and around the Cardinal Road Interchange where multi-family apartment units are likely to be constructed based on proposed County land use initiatives.
  - Continue to balance growth between Inverness Primary School, Pleasant Grove Elementary, and Floral City Elementary using the special attendance/ controlled open enrollment process.
  - Continue to monitor homeschool enrollment as these students can return to the schools at any time and this is most likely to occur in the upper elementary grades.
- 2. Readopt the current attendance boundaries for the middle schools for 2024-25.
  - Continue to balance growth between Citrus Springs Middle and Crystal River Middle using the special attendance/ controlled open enrollment process.
  - Continue to work with FDOT District 7, the MPO/County and the City of Crystal River to address traffic issues at Crystal River Middle

- School including the expansion of the parent pick up area and traffic circulation improvements as funding becomes available.
- Work with FDOT District 7 to help facilitate the planned 4-lane improvements to US-41 fronting Inverness Middle School and the City of Inverness to address traffic issues at Inverness Middle School when there are opportunities for cooperation.
- 3. Readopt the current attendance boundaries for the high schools for 2024-25.
  - Monitor growth in the Citrus Springs Community where the most recent attendance boundary changes were made for 2013-14. This has historically been a high growth area for high school student enrollment, and it was the location of extensive residential development activity in 2021 through 2023.
  - Monitor the enrollment in virtual programs during a temporary increase in overall high school enrollment. The use of portables at Lecanto High School will likely be necessary over the next 4 years to address a bubble in high school enrollment. The portables will be moved from Floral City Elementary and will be relocated to Lecanto High School if needed.
  - The overall high school enrollment will be balanced as much as possible through the Controlled Open Enrollment Process when practical.
- 4. Adopt the new 2024-25 Controlled Open Enrollment Plan with modifications as presented.
- 5. The following projects are recommended to address COFTE Projections and potential residential growth based in development review and permitting activity:
- Floral City Elementary additional student stations and cafeteria expansion -2023-24 (possible delays due to materials shortages)
- Crystal River Middle School additional parking and traffic circulation improvements - 2023-24
- Rockcrusher Campus master plan for temporary student stations, parking, traffic circulation improvements and an additional school site – 2024-25

It assumes Kindergarten enrollment to be unchanged from the previous year and PK enrollment is based on projected staffing and classroom availability. This information will be used as a starting point for more detailed enrollment projections by school and for the 2024-25 FTE Projections.

Additional information regarding the County and City projections of the amount, type, and distribution of population growth may be considered prior to finalizing the enrollment projections for 2024-25.

The differences between current enrollment (as of December 2023) and the 2024-25 preliminary projected enrollment are as follows:

• Elementary School Enrollment Change up 9 from 7,370 Middle School Enrollment Change = down 105 from 3,487 High School Enrollment Change up 137 from 4,484

#### Total Enrollment Projected Increase/Decrease = up 41 from 15,341 in December 2023

Last year the projected enrollment increase was 286 overall and this year it is 41 based on the January 2024 enrollment data used for first run projections.

\*Note: Preliminary elementary enrollment projections do not include factoring in birth rate changes from the previous year for Kindergarten and Pre-Kindergarten grade levels and they do not include growth projections from residential building occupancy changes at this point in the planning process. These enrollment projections represent a starting point in the enrollment projection process for 2024-25.

For 2024-25 additional enrollment projections may be necessary based on the enrollment growth that occurred in 2024 after the initial projections were made. Enrollment typically fluctuates in January from housing changes over the winter break.

In January 2024 elementary enrollment increased by 9 students from December 2023. From the Summer of 2023 to early 2024 residential building permit activity has slowed somewhat from the peak due to higher interest rates and overall housing costs.

Once the Floral City Elementary School expansion is complete, the focus will be on increasing capacity in the central ridge area and the central part of the County in general which also includes the Rock Crusher Area.

In 2023-24 the projected high school enrollment was 4,642 but the final enrollment was only 4,3484 so we had 158 less students than projected with the high schools at 90 percent utilization. The final tally was about 4 percent less high school students than projected.

For 2024-25 the projected high school enrollment is 4,621, an increase of 137 students which would put the facility utilization rate up to 93 percent. Lecanto High School is projected to be at 104 percent as compared to 100 percent at the end of 2023. High enrollment at Lecanto High School can be addressed by limiting acceptance of new students through the open enrollment process over the 2024-25 school year.

#### **Controlled Open Enrollment Plan Provisions**

### A. Eligibility Requirements:

- 1. All students shall be eligible to apply to attend an out of zone school unless they have been suspended or expelled from a school within the last six (6) months or suspended or expelled from another school district school in accordance with the provisions of Policy 5.20 Student Assignment.
- 2. All students must be enrolled at their home school if they are new students to the Citrus County School District prior to reviewing submitting a request to attend an out of zone school through the Controlled Open Enrollment Process.

## **B.** Application Process:

- 1. The application for Controlled Open Enrollment can be obtained from the Citrus County Schools Website for printing or at any of the schools in hard copy or it may be submitted electronically directly from the District Website.
- 2. The application is completed and signed by the parent or guardian and submitted to the Planning and Growth Management Department at the District Student Services Center or it can be dropped off at any school site and forwarded to the-Planning and Growth Management Department for processing. It may also be submitted directly from the District Website.
- 3. The Planning and Growth Management Technician will receive the application, assign a tracking number, and attach a review sheet for electronic routing to the school of choice for consideration.
- 4. The reviewing receiving school administrator will review the information provided by the applicant and the Planning and Growth Management Department. The receiving school administrator may utilize staff to help verify place of residence information provided by the parent/guardian if this level of verification is necessary.

- 5. The receiving school administrator will check one of the boxes on the review form that best describes the reason for approval or denial of the special attendance request as follows:
  - a) Approved Controlled Open Enrollment
  - b) Approved Special Program
  - c) Approved Zone Waiver
  - d) Denied because the request does not comply with the Citrus County School Board Attendance Zone Student Reassignment Policy/ Administrative Guidelines
  - e) Denied because the receiving schools projected enrollment exceeds capacity or because the school is in a high growth area and subject to substantial enrollment increases throughout the school year.
  - f) Denied because the receiving school is at or above 90 percent of the school or grade level capacity.
- 6. The application and review form are returned to the Planning and Growth Management Department for a final sign off and distribution to the impacted schools for enrollment purposes, and the parent/guardian is notified.

## C. Time period for accepting applications/ Controlled Open Enrollment Period:

Applications will be accepted beginning in Mid-March until May 26, 2023. May 29, 2024. Applications will not be accepted for processing after the controlled open enrollment period closes for schools unless the student's residence changes and the student wishes to stay at their out of zone school of choice, the student is enrolled in a special program, or a zoning exception is necessary for an ESE transfer, hardship placement, or other issue pursuant to the provisions of Policy 5.201 (X) Student Out of Zone Transfers / Choice.

## **D.** Method of determining capacity of schools:

Capacity of the schools shall be determined by the Department of Planning and Growth Management at the school level and by the Principal at the grade level. The basis will be the Florida Inventory of School House (FISH) Capacity and class size requirements as determined by the Florida Department of Education and either the projected or actual enrollment, depending on the time of year when the determination is made. Instructional Capacity is defined as 100 percent of FISH Capacity and Enrollment Capacity is defined as 90 percent of FISH Capacity.

### E. Enrollment and Capacity Report:

An enrollment report will be posted on the District Web Site that identifies the current projected or actual enrollment at each District School and the utilization rate for each facility.

#### F. Identification of schools that have not reached capacity:

Schools that have not reached capacity will be identified in green. Schools that have reached capacity will be identified in red and schools where grade level capacity may be exceeded for one or more grades will be identified in yellow.

#### G. Class Size Standards:

Class size standards shall be as required by the Florida Department of Education. For core curriculum classrooms that are pre-Kindergarten through grade 3, the class size is 18 student stations. For core curriculum classrooms that are grades 4 through 8, the class size is 22 student stations, and for core curriculum classrooms that are grades 9 through 12, the class size is 25 student stations.

# H. Lottery procedure for determining student assignment if transfer requests exceed available space:

When the number of applicants exceeds the number of available spaces the names will be placed in a "Random Name Picker" program such as the one found at the following web site <a href="http://www.miniwebtool.com/random-name-picker/">http://www.miniwebtool.com/random-name-picker/</a> or a similar system where the names are picked using a random process.

## I. Provision for a parent to request placement of siblings within the same school:

Siblings residing at the same address will be placed together subject to school capacity unless it is determined that placing them in the same educational setting would not be in the child's best interest.

## J. Appeals Process:

The appeals process is administered by the Department of Planning and Growth Management. Appeals must be filed after a determination is made by the receiving school principal and must include the reason for the appeal and any supporting documentation.

### **K.** Availability of Transportation:

Students attending an out of zone school may utilize the closest bus stop within the school zone subject to bus capacity. Out of zone transportation is provided for students enrolled in school specific special programs such as the Computer Science Academy at Citrus High School, Health Academy at Crystal River High School and the Art Academy and International Baccalaureate Program at Lecanto High School as approved by the School Board. Other students enrolled in an out of zone school will not be provided transportation.

### L. Automatic Approval Process for Students that Move out of Zone:

In the case of a student changing residence during the school year, the Department of Planning and Growth Management shall create a new special attendance preference record for the student so they may remain at the school in subsequent years until the student completes the highest grade level at the school unless the student is suspended or expelled from the school. In order for the school choice application to be processed when a student moves out of zone, the school must confirm that the student moved out of zone and provide the address change to the Department of Planning and Growth Management when requested. If the student is suspended or expelled from the school, the reassignment may be rescinded. Transportation shall not be provided for students who reside out of zone unless the student is enrolled in a special program and the School Board has approved out of zone transportation for the particular program.

## M. Method and timeline for notifying a parent of his/her child's placement for the next school year:

Parents/guardians are notified by US Mail within 30 days after a determination is made that the student can be placed in the receiving school of choice.

## N. Out of County Students:

- 1. Students residing in the District shall not be displaced by a student from another district who is seeking enrollment through the open enrollment provisions.
- 2. A student whose parent is transferred, or is pending transfer, to a military installation within the state while on active military duty pursuant to an official military order shall be considered a resident of the school district for purposes of enrollment when the order is submitted to the school district, and shall be provided preferential treatment in the controlled open enrollment process of the school district pursuant to Section 1002.31, F.S.

### O. Family Empowerment Scholarship Recipients:

If a child is the recipient of a Family Empowerment Scholarship the request will be reviewed as follows:

- 1. Family Empowerment Scholarship for Educational Options (FES EO) The FES EO request will be reviewed by the Department of Planning and Growth Management for administrative placement subject to school capacity.
- 2. Family Empowerment Scholarship for Students with Unique Abilities (FES UA) The FES UA request will be reviewed by the Exceptional Student Education Department for administrative placement subject to school capacity.

### P. Required Preference Criteria:

Preferential treatment shall be provided for the following students:

1. Dependent children of active duty military personnel whose move resulted from military orders;

- 2. Children who have moved due to foster care placement in a different school zone;
- 3. Children who have moved due to a court-ordered change in custody as a result of separation or divorce;
- 4. Children who have moved due to the serious illness or death of a custodial parent;
- 5. Students at multiple session schools; and
- 6. Students residing in the District.

### Q. Wait List for Placement at School of Choice:

- 1. A wait list of students who are denied access due to capacity will be maintained at the school of choice for the duration of the year in which the application is made.
- 2. If space becomes available, the student will be notified by US Mail throughout the school year in which the application is made.

# R. Controlled Open Enrollment Suspended for Two (2) School Years Following School Attendance Boundary Changes/ Rezoning

If a school attendance boundary is changed by the School Board in order to reduce enrollment, and increase capacity in a school, Controlled Open Enrollment will be suspended and not allowed for two (2) school years to allow for the attendance boundary change/ rezoning to achieve the necessary reduction in school population.
