**Violations Comments**

Violation #22. Cold holding temperatures observed prepackaged broccoli on the line @ 44 F. advised staff to place broccoli into shallow perforated pan, and then place that pan into a pan with ice in it. corrected on site.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.

Violation #44. Equipment & linens: stored, dried, & handled observed multiple pans which were wet nesting in storage after being washed/sanitized. staff removed from storage and rewashed, sanitized and dried. corrected on site.

CODE REFERENCE: 64E-11.003(4). Utensils and equipment must be cleaned, sanitized and air dried prior to storage. Utensils, equipment, and linens must be properly cleaned and stored.

satisfactory inspection. prepackaged broccoli on line @ 44 F, turkey salad in stand-up cooler @ 41 F, teriyaki chicken on line @ 142 F, rice on line @ 156 F, mozz stix in stand-up warmer @ 136 F, OJ in grab-n-go cooler @ 39, milk in walk-in refrigerator @ 36 F, prepackaged sliced oranges in walk-in refrigerator @ 35 F. ensure all cold food items which are not on the time as a public health control list are held at a temperature of 41 F or below.
