**Violations Comments**

**Violation #22. Cold holding temperatures**

Observed salads set for service that ranged from 64F, 70F, and 76F in the upright reach in cooler. Appears that chicken put on salads was still in the cooling process when used to top salads-had to make additional chicken for salads-still within cooling period after making. Items held for cold holding must be kept at a temperature of 41F or below. Salads were moved to freezer for quick chill. Corrective action taken.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.

**Violation #24. Time as PHC; procedures & records**

Did not observe times for when sliced cucumbers were removed from temperature control and put on line and time when corn and taco meat was portioned up and put on line. Ensure that when time items are removed from temperature control that time is written on log. Times written. Corrected on site.

CODE REFERENCE: 64E-11.003(2). The food establishment has submitted a procedure and received prior approval to use TPHC. Proper documentation is available.
